By default, wire transactions will now show "required fields" only. All optional fields, including "Message to Beneficiary," can now be found in the "Optional Fields" drop down.

### Purpose of Wire

Many countries and some US banks are now requiring a "Purpose of Wire" before accepting an incoming wire. To ensure that this information is included with your outgoing wires and to reduce the chance of delayed processing by the beneficiary bank, all wires input through online banking will be required to have a Purpose of Wire.

For clients with existing wire templates, the next time you use a template, you will need to input a Purpose of Wire. This information will be saved to the template and you will not need to input it the next time you use that template.

So in this update there is now a single view that offers all of the functionality available previously – including the ability to select multiple transactions at one time and approve, cancel, or print them.

### **Positive Pay**

Positive Pay will now feature the ability to make Pay/Return decisions and add single issue checks from either desktop, tablet, or mobile phone. This release will be for **checks only**.

In this update you will experience a new workflow for ACH Credit Payment. Follow the prompts, inputting all necessary information to initate the transfer. On the final tab, Review and Submit, you will be asked to specify an Effective Date. If you would like to initiate a Same Day ACH and it is before the 8:30am deadline, you will be able to select today's date.




